BACKGROUND INFORMATION

The Network of African National Human Rights Institutions (NANHRI) is a regional umbrella non-profit organization with a membership of 46 African National Human Rights Institutions (NHRIs). NANHRI endeavours to capacitate NHRIs with the necessary knowledge, skills, tools, and techniques to enable them to undertake their mandate of human rights protection and promotion in line with the Paris Principles. The secretariat of NANHRI which is based in Nairobi achieves this through facilitating and coordinating efforts amongst NHRIs and linking them to other key human rights actors at the regional and international levels. With funding from HIVOS International, NANHRI is implementing a Sexual Reproductive Health and Rights (SRHR) programme dubbed *WeLead*, in Kenya, Uganda, Nigeria and Niger.

The project's strategic objective is that by the end of 2025, resilient young women with disabilities, living with HIV or affected by displacement, play a leading role in strengthened and inclusive organizations and movements that enjoy increased public support and have convinced duty-bearers and health-service providers to take steps towards implementing laws, policies and practices that respect and protect these young women's SRHR.

NANHRI seeks to support and strengthen NHRIs in Africa as well as to facilitate coordination and cooperation among themselves and between them and Communities of Action ((COAs) and rightsholders. Pursuant to its mandate, NANHRI will conduct a capacity building workshop for the aforementioned on mainstreaming Sexual Reproductive Health and Rights (SRHR) protection.

Sexual and Reproductive Health (SRH) is a human right that is essential to human development and the achievement of the Sustainable Development Goals. SRH accounts for at least 20 per cent of the burden of global ill health for women of reproductive age, and 14 per cent for men. It is based on this background that NANHRI seeks to contract the services of a consultant to conduct a two-day in-country workshop on SRHR in Nigeria.

MAIN TASKS OF THE CONSULTANT

The Facilitator will, in close collaboration with the Programme Officer, perform the following tasks:

- 1. Design the programme of a 2-day workshop, including its process and methodology, and detailed guidelines for inputs from workshop participants).
- 2. Facilitate sessions on:
 - Achieving progressive realization of sexual and reproductive health and rights (country status)
 - Enhancing the capacity of NHRIs on regional engagement (Maputo Plan of Action, Abuja Declaration, ICPD, 2063, Maputo Plan of Action, Campaign on Accelerated Reduction on Maternal Mortality in Africa (CARMMA), etc., localization of global and regional SRHR, drafting of alternative reports and following up with Universal Periodic Reviews recommendations)
 - Role and Responsibilities of NHRI, duty-bearers, CSOs and rightsholders in protecting SRHR
 - Linking and Learning in SRHR (enhancing synergies between NHRIs, CSOs, duty-bearers and rightsholders)
 - Lead and provide expert input on specific workshop sessions (national and regional SRHR engagements)
 - Guide in development of an action plan towards the end of the workshop that can be assessed over the implementation period.
 - Encourage constructive debates, maximum and participatory dialogue during all sessions
 - Bear overall responsibility for facilitating the 2-day workshop, ensuring that it achieves its objective

3. IV. EXPECTED OUTPUT

The Facilitator shall be responsible for facilitating sessions during the In-country Workshop, manage a coherent workshop resulting into good advocacy strategies in advancing the realization of SRHR, provide technical advice and support to participants during the workshop on **6**th – **7**th **September, 2023.** Finally, shall submit a report upon completion of the workshop.

DURATION OF THE TASK

The work will be done for a total of 4 days. The facilitator will have one day to discuss and develop the workshop programme in consultation with the Programme Officer and organize session's coordination, two days of workshop facilitation and a day for compiling workshop report.

ORGANISATIONAL POSITION

- The Consultant will work in close collaboration with the WeLead Programme Officer
- The Consultant will be line managed by NANHRI

COMPETENCIES AND QUALIFICATION OF THE CONSULTANT

- i. At least a Master's Degree or equivalent in Law, Reproductive Health, Public Health, Public Policy, Sociology, Development Studies, Economics or related Social Sciences.
- ii. Demonstrable relevant working experience in the health sector of at least 10 years preferably on SRHR, policy and advocacy at national and regional level including working with NHRIs.
- iii. Should be able to communicate effectively in French (English will be an added advantage)
- iv. Hard-working, collaborative, and committed to NANHRI's values
